Minutes of the Twenty Second Meeting.

1. The Twenty Second meeting of the Internal Quality Assurance cell started at 10:00 am on 19/04/2021 in the IQAC room. Direction of the institute Rev. Fr. Paul Nedumpurath presided the meeting. Rev. Fr. Paul congratulated the efforts made by NBA team in submitting the NBA compliance report of five programs to NBA portal on 22nd February 2021. Rev. Fr. Paul highlighted the positive sides of institute accreditation.
2. Dr. K.K. Rajan instructed to conduct the internal auditing of course files of odd semester at the earliest. It was informed the submission procedures/ application for the new program. "Computer Science and Design" to AICTE is complete.
3. Regarding Valuation Camp, Dr, K.K. Rajan instructed the Head of Departments to make sure the examiners from our college are reporting for the valuation and completing valuation on time. It was informed that institution should open an account with NDML Academy depositing services. Where certificates of students who have passed from the college be stored for future retrieval.
4. Dr. K.K. Rajan informed the subject allocation for semester 2 and 4 be completed and handed over to the time table committee so as to complete the time table for semester 2 and 4 classes. The first series examination for semester 8 classes be started from 26.04.2021 and semester 6 series examination in the second week of May 2021.
5. Dr. K.K. Rajan suggested the Head of Departments to ensure functioning of CGPU to improve the placement activities. It was informed the college is planning to start a new wing to support the students who would like to undergo higher studies abroad especially in German speaking countries. It was informed a new project lab would be setup with the latest Personal Computers which students of Artificial Intelligence, Computer Science Engineering and Information Technology department could utilize.

10. Dr. K.K. Rajan instructed that the course Diary be complete in all respect.
11. Sri. Somy P. Mathew informed the semester 6 series exam would commence from 10-05-2021
12. The help of Alumni could be utilized for arranging Mock interview for final semester students. Company specific training be well prepared before test and interview.
13. Rev. Fr. Paul mentioned, the participation of students also could be utilized for social media plan coverage.
14. Dr. K.K. Rajan informed the work from Home pattern will be followed as and when required based on Government orders. It was informed all the staff members are actively participating in parting the contents and increase the publicity and visibility of VJCET.

16. It was informed Head of Departments should make sure that proper maintenance be done in laboratories and workshops to keep all the equipments in working condition.
17. Dr. K.K. Rajan informed the semester 8 examinations fees students will be conducted as Online examination between June 28th and July 12th 2021.
18. Rev. Fr. Paul informed the management has decided to postpone the last date to remit the fees for semester 4 students without fine to June 30th. The last date to remit fees is as July 12th. From July 1st to July 12th Rs. 500/- would be charged as fine. The arrangement is made considering the pandemic situation.
19. It is informed that Yoga day will be celebrated on 21st June 2021 by Mechanical Engineering Department.
20. Dr. K.K. Rajan informed this year the college would invite application fees M.Tech program. 18 seats for CS, VLSI program and 9 seats for IEM program. The semester fee would be Rs. 25,000/-
21. Dr. K.K. Rajan informed the University would like to train a set of mentors to support the students and hear their concerns due to prevailing pandemic. It is suggested to nominate two faculty members from institute for the same.
22. Dr. Cyriac Joseph opined that during PTA meeting the previous semester University exam results should be informed to the parents. It was suggested remedial classes should be given to students for the supplementary subjects of previous semester.
23. Smt. Shine George intimated that the course incharges must check the course plan, delivery plan and submit a report to the assessment committee in the required format. In the case of final year students, it is insisted to concentrate on their project and be ready for verification of projects.
24. Smt. Ann Neetha informed second series for semester 1 students was conducted in March. The first series exam fees semester 8 was conducted in April. All the series examinations were held in online platform.
